### Equality Day 2006 in Olympia: Monday, January 23

Equal Rights Washington and the Religious Coalition for Equality are organizing Equality Day 2006 in Olympia to educate people about the issues involved with marriage equality and anti-discrimination legislation, to provide education about how to visit with legislators effectively and easily, and to again show support for marriage equality and anti-discrimination legislation.

If you were at the Valentine's Day Rally last year, you know what an exceptional, exciting, exhilarating day it was. If you were not there, you will not want to miss this year's event.

Members of the Seattle Men's and Women's Choruses will again sing. Dynamic religious leaders will speak, and we will hear from prominent elected officials.

#### **Schedule and Details**

9:00 - 9:30 Coffee and donuts

**9:30 - 11:15** Advocacy Workshops: Come to the Rally early and learn how to ask your legislators to support Marriage Equality and to support legislation which prohibits discrimination based upon sexual orientation.

Legislators and experienced lobbyists will provide helpful tips about how to approach your legislators and how to explain to them the reasons to support our issues.

Representatives of Equal Rights Washington and the Religious Coalition for Equality will discuss the message we want to convey to our legislators and provide key talking points.

We will have sessions for those who may be visiting legislators for the first time, as well as seasoned veterans.

You will have an opportunity to meet people from around the state and from your own legislative district as we prepare to march on the Capitol in support of Marriage Equality and anti-discrimination legislation.

11:45 - 1:00 Rally on the Capitol Steps: The debate over rights for sexual minorities has reached new intensity. Courts in King and Thurston Counties have declared the Washington Defense of Marriage Act (DOMA) unconstitutional. The State Supreme Court will uphold or strike down those decisions. If upheld, there will be a move to amend the state constitution to prohibit same-sex marriages. If struck down we want DOMA repealed.

Legislation to include sexual minorities in the state civil rights came within one vote of passing last session. We want it to pass this year.

We know voices from faith communities have been the most vocal opponents of liberty. It is time for other voices to be heard.

More than 250 Clergy from our diverse faith communities have signed a statement calling for marriage equality for all. We are proud signers. Now is the time to do more. In order to be heard we will rally on the capitol steps in Olympia on January 23, 2006. Come and be with your clergy in religious garb and members of our faith communities in support of a more compassionate vision within our faith perspectives. Come and be with people from all across the state who support marriage equality.

We need two or more people from each legislative district who support marriage equality. We will train you in the morning and ask you to meet with your representatives following the rally. You can help our voices of faith be heard.

Whoever you may be, if you revere all persons and hold their rights in equal esteem, attend the rally in Olympia. Invite others to attend. Bring a car pool.
