## Northwest AJDS Walk

Saturday, September 9th, 8:00 a.m. Volunteer Park, Seattle

Hello Dignity/Seattle friends;

I am writing to ask your support for Lifelong AIDS Alliance's 20th Annual AIDS Walk on Saturday, September 9, at Volunteer Park in Seattle. Registration is at 8:00 a.m., opening ceremonies at 9:00, and the walk, which begins and ends at the park, starts at 10:00.

This year marks 25 years since the first cases of what later came to be called AIDS were diagnosed. This year is also the 20th anniversary of the AIDS Walk here in Seattle. The funds raised from the AIDS Walk go to the direct services Lifelong AIDS Alliance provides to its' clients: Case management to connect clients with the medical & social services they need; Transitional and permanent housing for people who would otherwise be homeless; Medical insurance premiums for clients who would otherwise be uninsured; Education and prevention efforts in schools, churches, and other communities, especially communities of color and immigrants; The Chicken Soup Brigade food program to provide groceries and hot meals tailored to each individual's diet needs (this program now also serves people with other lifechallenging illnesses, especially those with MS and kidney disease); Advocacy at the state and federal government levels to help insure funding for AIDS research, treatment, and practical support.
