Domestic Partnership Bill

Passes Washington State Senate March 1st Marriage Equality Bill fails committee

On March 1st, just three days after "Equality Day" at the State Capitol in Olympia, the Washington State Senate voted in a strong majority 28-19, with two abstentions, to allow gay & lesbian couples and unmarried senior citizens to register and secure domestic partnership benefits. The vote was very much along party lines, although four Democrats and one Republican voted against their caucuses.

The State House of Representatives, which will next consider the legislation, is also expected to pass the bill very easily since Democrats hold a 62-to-36 seat advantage over Republicans. Governor Christine Gregoire (D) has indicated she will sign the bill into law when it reaches her desk.

The bill will confer inheritance rights, health care power of attorney, funeral arrangement rights, and organ & tissue donations to gay & lesbian couples and senior citizens over 62 years of age who register with the state and meet certain living arrangement criteria. The decision to include senior citizens was both a calculated political strategy and a matter of fairness for social security beneficiaries who stood to lose deceased spousal benefits upon remarriage.

State Senator Ed Murray (D-Seattle) shepherded the bill through the Senate; last year, as State Representative in the House, he spearheaded the successful effort to pass the "Gay Civil Rights Bill."

The good news about the pending domestic partnership law becoming a reality is tempered by the failure of the sister "Gay Marriage" bill to get out of committee this legislative session. Proponents of marriage equality acknowledged the difficult political climate for such new, radical legislation, but vowed that this was the first salvo in what is expected to be a multiyear, protracted struggle. Unlike the 29 years it took to pass the Gay Civil Rights Bill, marriage equality is expected to become politically palatable perhaps as early as within five years, according to many observers. The soon-to-be enacted domestic partnership bill is viewed as a first step, correcting some of the most egregious discriminatory provisions of current law.

Washington State will soon join a handful of states that have recognized at least some partnership rights for gay and lesbian couples.

Gay marriage: Massachusetts.

Civil unions: Connecticut, Vermont, New Jersey.

Domestic partnerships: California, Maine, Hawaii, District of Columbia.

Pending domestic partnership legislation: New Hampshire, New Mexico, Oregon, Washington.

Despite slow but palpable progress, political leaders are calling for vigilance, since radical right wing activists are already gathering signatures to repeal both last year's Gay Civil Rights Bill and this year's Domestic Partnership Bill through ballot initiatives.

The situation just 120 miles north of Seattle is unbelievably more progressive: Canada has legalized gay marriage at the federal level, becoming only one of five nations to do so (the others are The Netherlands, Belgium, Spain and South Africa). Over a dozen other nations, mostly in Europe, recognize samesex civil unions.
