# Robert Blair Kaiser Now We can Reclaim Our Church

Robert Blair Kaiser, Catholic journalist and author, went through ten years in the Society of Jesus, then, three years shy of ordination, left the Jesuits to pursue a career in journalism. He covered the Second Vatican Council for *Time* magazine in the 1960s, worked on the religion beat for *The New York Times* in the 1970s, and served as journalism chairman at the University of Nevada-Reno in the 1980s. Four of his eleven published books deal with the Catholic Church: *Pope, Council and World; The Politics of Sex and Religion; Clerical Error* and his current work, *A Church in Search of Itself.*

#### A first step: Washington State recognizes domestic partnerships!

On April 21, 2007, Governor Christine Gregoire signed legislation that recognizes domestic partnerships for gays & lesbians, as well as for seniors over 62 years of age. The measure passed the Senate 28-19 in March and the House 63-35 in April, mostly along party lines. Passage of domestic partnership is but a first step toward civil unions, and eventually the goal of marriage equality for all citizens.

We are still donating proceeds from the Breakfast and Raffle to Multifaith Works, Verbena and Dignity. Jim Rankin will send out letters to ask for raffle donations from merchants this next week.

#### **New Business:**

- Membership in the LGBT center has increased to \$150.
   M/M/S/C: To pay membership for this year.
- Per Leo's e-mail request, the board agreed to place a link between St. Ignatius and Dignity on the website.
- Silent Auction for DignityUSA convention: Different cities have put together "travel baskets" to entice people to come to their city. DignityUSA is encouraging us to come up with a "travel basket" of our own. Delia will call the City of Seattle to see if they will donate free passes to popular local places such as the aquarium and zoo and will include them with items such as the "Over Washington" video, which Paula and Tish have already purchased.
- Donation to DignityUSA Convention: Various DUSA chapters have agreed to underwrite travel expenses for speakers. Paula L. asked if we wish to do the same. The Board decided to donate \$300 from our savings for general expenses related to the Convention to DUSA instead.
