- Decision made to have a Birthday/Anniversary potluck on Saturday, December 5 at 4:00 p.m. instead of a restaurant brunch. A location or host for the potluck needs to be found.
- Following Birthday/Anniversary gatherings are to alternate between a restaurant brunch for spring and summer quarters, and a late afternoon potluck for winter and summer quarters. It is the intent to encourage families with children for the winter and summer quarter potlucks.

Liturgy Committee: (Denise Arceneaux)

Fr. Philip Knowles to preside in October. Considering John Reardon when Philip is unavailable.

Membership Committee:

The mass en mass on August 30 at 7:00 p.m. at St. Benedict's with get together for coffee or food afterward was well attended with a number of favorable comments. Future mass en mass gatherings are planned for alternating months with the next being in November.

Old Business:

- DignityUSA Scholarship Fund: \$200 of the scholarship fund divided by 10 participants will be disbursed to those who went to the Convention. Some participants are re-gifting the amount back to the fund.
- The RUMC sign to which \$100 was contributed has an incorrect start time for the Dignity service. The incorrect 7:00 p.m. start needs to be corrected to 6:00 p.m.

New Business:

- Recent content of the Dignity/USA conference call was discussed with focus on means of outreach.
- Paula to contact Sister Bea to discuss service project opportunities for January. Activity should focus in areas isolated from customers, thereby allowing children to participate.
- Discussion to contact the UW Newman Center.

 Discussion in ways to help Equal Rights WA with "Yes on Ref 71." Considerations are to endorse on the Dignity/Seattle website including a webpage statement. Other thoughts are towards a special email, volunteer for the phone bank 6pm through 9pm (Monday through Thursday), letters to editors in eastern WA newspapers, and help with fund-raising.

M/M/S/C: To include a statement on the Dignity Seattle website with links to Equal Rights WA Ref 71 webpage. To send emails to social list in support of Ref 71.


• Discussion on voice mail options to replace the current \$45/month charge. "My1Voice" \$10/month + tax service allows keeping the existing phone number and routes voice mail to email. Concerns were the apparent inability to maintain a published listing in the Dex phonebook. Sign-up on "My1Voice" would require a credit or debit card which should be easily available from the bank. Michael to further research "My1Voice" features and requirements.


M/M/S/C: Delia to obtain a debit card.
