M/M/S/C: To accept the July 24, 2013 financial report as submitted.

Old Business:

- Pride breakfast: M/M/S/C: to divide the Pride Week Breakfast proceeds into \$700 for Bailey-Boushay, \$700 for Rosehedge Multifaith Works, and \$636 for Dignity/Seattle. Alan Scott indicated that there was no sign indicating that the parking lot adjacent to Central Lutheran was open for the breakfast and that there was no warning sign indicating that the parking spots across the street were paid parking and that we should have these signs in the future. We should also have some device separating out the raffle tickets.
- 2013 Convention: The Board decided to pay Paula H. from the Convention Restricted funds for the sunglasses and then to divide the rest of the funds among the 7 people who attended. Delia will write out the checks to them.
- 2015 Conventions: National Convention meeting is in August. They will be discussing general broad topics for speakers. If you know of any speakers or have any ideas let Paula L. know so she can bring them up at the meeting. Paula L. is planning to start a planning committee in the fall for the Convention so we can look into cruises, etc. that people can go on while they are here. She will also start a column in the Dateline for Seattle soon. If anyone is interested in helping, let Paula L. know.
- 40th Anniversary Celebration: Alan will send out invitations with Paula L.'s and Delia V.'s help. The board decided to extend an invitation to someone from national paying their way from our funds. Paula L. will see if Leo can update the history book.
- Newsletter: Delia will look into printing the newsletter.
- Food Lifeline is scheduled for August 6.
