#### **Old Business:**

- Food Lifeline: Seven members and friends volunteered for the February 7th Food Lifeline work party to inspect, select the good, and box assorted pears. The next Food Lifeline volunteer evening is set for Tuesday, April 4.
- Paula H. will set up a meeting with Gary Southerton and other Dignity/Seattle members to discuss liturgy options.

#### **New Business:**

- Pride Breakfast: Charities to benefit from this year's breakfast were discussed. Delia will investigate donating to Lambert House to possibly replace one of last year's charities (CareTeams at Samaritan Center and Plymouth Healing Communities and Food Lifeline). Delia has reserved the Central Lutheran Church Hall for this year's Breakfast on June 24. Delia will prepare an advertising flyer to be sent to the soon to be designated charities. The board approved the \$100 SGN advertising expense. Delia will contact the SGN to place a one-quarter page ad in the June 16 and June 23 issues. Delia will contact prospective raffle and breakfast supply donors. Alan will print tickets, envelopes, and letters in April and stuffing envelopes will occur on May 3rd. As a few of last years servers will not be available for the Breakfast, additional servers will be needed.
- Second quarter brunch date was set for May 13 subject to confirmation from McMenamins QA. Alan will contact McMenamins to confirm.
- The Summer Picnic held in previous years at Lower Woodland Park will be held at the home of Becky Ortiz in north Seattle beginning 1:30 p.m. on Saturday, August 5th.
