- Dignity/Seattle has an open invitation to join RUMC and St. Ignatius in a combined 10am Easter Mass.

Combined Old Business and New Business:

- 27th Annual Pride Breakfast: The Central Lutheran Church Hall has been reserved for June 27. As so few breakfast attendees showed prior to 9:00 a.m. in earlier years, the board adjusted the breakfast start to 9:00. The raffle drawing at the end of the breakfast remains as 12 noon. Delia is to contact vendors. Alan to print letters and tickets with the 9am start time in bold type. Paula L. to purchase food and coordinate volunteers. The breakfast cost is to remain at \$7. A number of charities are being considered as Pride Breakfast profit beneficiaries. Delia is to place a 1/8th page sized ad with the SGN to appear the week before Pride.
- Food Lifeline Volunteer Evening: Despite a low turnout of volunteers for the bi-monthly Food Lifeline work party, a unanimous decision was made to continue with this charitable event. Attendees report having an enjoyable time while socializing during the short twohour work party and gain a sense of reward through the expressed appreciation of the Food Lifeline host.
