#### Social Committee: (Alan Scott and Delia Vita)

- Five attendees enjoyed good food and pleasant company at Julia's of Wallingford during the first quarter social brunch on January 30.
- June 4 was the selected date for the second quarter brunch to be held at McMenamin's on Queen Anne.
   Alan will contact the restaurant to check availability.
- Seattle Parks and Recreation received Dignity/ Seattle's \$80 check and provided a permit to occupy Lower Woodland Park Shelter 7 beginning at 3:00 p.m. Saturday July 23,.

#### **Old Business:**

- Food Lifeline: The next volunteer evening is set for Tuesday, April 5. Following discussion a decision was made to resume the bimonthly volunteer activity at their new South Park facility preferably on the first Saturday morning of even numbered months beginning in October. Paula L. will contact the volunteer coordinator with this preferred option.
- Pride Breakfast: Breakfast price to remain at \$7 per person and to serve during the three-hour time period from 9:00 a.m. to 12:00 noon. Charities to benefit from this year's Pride Breakfast were discussed. In addition to last year's charities (CareTeams at Samaritan Center and Plymouth Healing Communities), Paula L. will investigate donating to Mary's Place, and Food Lifeline. Delia will reserve Central Lutheran Church Hall and prepare an advertising flyer to be sent to the soon to be designated charities. Alan to print the breakfast letter, tickets, and envelopes.

Together with a few other organizations, a total of almost 1,400 pounds of coconut were bagged to provide over 11,000 servings for the hungry people in Western Washington.
